

LONE PEAK STUNTING WAIVER AND RELEASE OF LIABILITY

DISCLAIMER: Lone Peak cheerleading (administration, coaches, cheerleaders or anyone otherwise associated) is not responsible for any injury (or loss of property) to any person while practicing or participating in clinics, demonstrations or in any other way involved in cheerleading, stunting for any reason whatsoever, including ordinary negligence on the part of the cheerleading program.

In consideration of my participation, I hereby release and covenant not-to-sue Lone Peak and anyone associated with the program from any and all present and future claims resulting from ordinary negligence on the part of the Lone Peak for property damage, personal injury, or wrongful death, arising as a result of my engaging or receiving instruction in stunting, cheerleading, or any other activities or any activities incidental thereto, wherever, whenever, or however the same may occur. I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and future, that may be made by me, my family, my estate, heirs, or assigns.

Further, I am aware that cheerleading and stunting are vigorous sporting activities involving height and rotation in a unique environment, and as such pose the risk of injury. I understand that cheerleading, and related activities always involve certain risks, including but not limited to, death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage, and serious injury to virtually all bones, joints, muscles, and internal organs, and that the mats, pits, and other safety equipment and apparatus provided for my protections, including the active participation of a coach or teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent serious injury. I am voluntarily participating in this activity with knowledge of the risks involved and hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

I further agree to indemnify and hold harmless Lone Peak, and associated with the program for any and all claims arising as a result of my engaging in or receiving instruction on Lone Peak property, whenever, wherever, or however the same may occur.

I understand that this waiver is intended to be as broad and as inclusive as permitted by the laws of the state of Utah and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be within the state of Utah.

I understand that this waiver is a supplement to any other waiver signed for participation in the Lone Peak program and does not replace any documents. I also understand that without this waiver, I will not be allowed to participate in any stunting in the program.

I have read this form and fully understand that by signing this form, I am giving up legal rights and or remedies which may be available to me for the ordinary negligence of Lone Peak.
